CHILD SAFEGUARDING STATEMENT OF OPEN SPECTRUM CLG

Open Spectrum provides extra-curricular activities for children up to the age of 18 who are on the autistic spectrum. Our volunteer-led service is designed around the needs of children and we comply with all national legislation and guidelines to promote the safety and well-being of our participants.

RISK ASSESSMENT

We have carried out an assessment of any potential harm to a child while availing of our services. Below is a list of the areas of risk identified and the list of procedures for managing these risks.

- PHYSICAL INJURY: Premises for each activity are inspected by the Health and Safety Officer of Open Spectrum. Each child's parent/guardian is on site or within reach by phone during the activity. A First Aid kit is with the Parent Co-ordinator onsite. In case of serious injury, the coach will call emergency services.
- 2. Fire safety standards and drill have been checked and shared with the coach by the Health and Safety Officer. The coach is responsible for evacuation.
- 3. RISK OF DISTRESS TO A PARTICIPANT CAUSED BY ANOTHER PARTICIPANT: All participants have subscribed to the OS Code of Conduct. The Parent/Guardian of each child is on site or within reach by phone. If agreement is not reached, the participant(s) accused of causing distress may be asked to withdraw from the activity.
- 4. RISK OF DISTRESS BY PARTICIPANT CAUSED BY PARENT/GUARDIAN:
 Parents/guardians have subscribed to the OS Code of Conduct. If agreement to
 desist is not reached between parent and coach, the parent accused of causing
 distress may be asked by the coach to withdraw from the activity.
- 5. RISK OF FLIGHT: Premises for each activity are inspected by the Open Spectrum Health and Safety Officer. Appropriate coach: participant ratios are maintained. Parents/guardians are on site or easily reachable by phone.
- 6. RISK OF ABUSE OR EXPOSURE TO INAPPROPRIATE BEHAVIOUR BY COACH/VOLUNTEER: Open Spectrum coaches and volunteers are garda-vetted and subscribe to the Open Spectrum Code of Behaviour for Open Spectrum coaches and volunteers.
- 7. PROCEDURES: Our Child Safeguarding Statement has been developed in line with requirements under the Children First Act 2015 "Children First: National Guidance for the Protection and Welfare of Children 2017" and Tusla's Child Safeguarding: A Guide for Policy, Procedure and Practice. 1. Procedure for the provision of and access to training and information regarding the safeguarding of children including the identification of occurrence of harm; 2. Procedure for the reporting of serious concerns regarding the welfare of children to Tusla.

IMPLEMENTATION

We recognise that implementation is an on-going process. Open Spectrum CLG is committed to the implementation of this Child Safeguarding statement and the procedures that support out intention to keep children safe from harm while availing of our service. This Child Safeguarding Statement will be reviewed on January 1st 2027 or as soon as is practicable after there has been a material change in any matter to which the statement refers.
